PRIVACY POLICY

Third Parties with which Your Personal Data is Shared:

- When you use CMC services, we share your data only to the extent necessary to enable you to use the services (for example: when you share content, when you search for content)
- We may share it in case of any dispute or legal process between you and CMC and/or other third party users.
- We may also share your personal data with companies and organizations associated or affiliated with CMC, such as subsidiaries, affiliates and parent companies, provided that their use of the data clearly complies with this policy.
- If people using the following social media accounts send us their complaints and questions via private messages, these conversations are recorded by us and the recordings of such conversations can be shared with legal entities pursuant the service agreement between such legal entity and CMC.

h) Objecting to adverse consequences arising from the analysis of the processed data exclusively via automatic systems,

i) Claiming compensation in case you suffer any loss due to illegal processing of the personal data.
